比賽章則

1. 賽制

- 1.1 一般規定,請詳見「校長盃通則」。
- 1.2 每場比賽為五盤三勝制,每盤三局兩勝,每局先取二十一分者獲勝。若雙方比分為 20:20 會進入平局(Deuce),連續取得兩分者獲勝。平局進行至 29:29 時,先取得第 30 分者獲勝。
- 1.3 比賽次序: (i) 男子單打 (ii) 女子單打 (iii) 男子雙打 (iv) 女子雙打 (v) 混合雙打。若有需要, 比賽次序可由主委作調動。
- 1.4 每名球員在每場比賽中,最多只能參加一盤單打及一盤雙打比賽。
- 1.5 參賽隊伍最多可派出一名非宿生(全日制本科生、副學士及高級文憑學生或教職員)作賽。

2. 規則

2.1 除賽會特別訂明外,其他規則一律採用最新國際球例。

3. 報名

3.1 每宿舍限報一隊。

4. 裁判

- 4.1 裁判由大會安排。
- 4.2 比賽時,出賽隊伍須各派兩名同學出任司線員及核對分數。

5. 棄權

- 5.1 參賽隊伍須於比賽時間前5分鐘(依大會計時為準)向主委提交出場名單,否則作棄權論。
- 5.2 球賽進行中之任何爭議,倘已明文規定者,或有同等意義註明者,由裁判判定,不得異議。比 賽須繼續進行,如有隊伍放棄繼續比賽,作棄權論。

6. 其他

- 6.1 比賽用球由賽會提供。
- 6.2 本比賽章則如有未盡善之處,主委得隨時修訂。

2021-2022 Lingnan University President's Cup

Badminton - General Rules

1. Format

- 1.1 For the general rules, please see the 'President's Cup General Rules'.
- 1.2 A badminton match consists of the best of 5 games. A game consists of the best of 3 sets of 21 points. When the set is tied at 20-20, the side which first gains a 2 point lead will win the set. If the set reaches 29-29, the side scoring the 30th point will win the set.
- 1.3 Order of play: (I) Men's Singles (ii) Women's Singles (iii) Men's Doubles (iv) Women's Doubles (v) Mixed Doubles. If necessary, the order can be arranged by the convenor.
- 1.4 Each player can only participate in one Singles or/and one Doubles.
- 1.5 Only one non-resident (full-time undergraduate, associate degree and higher diploma student or staff) can represent the hostel to participate in the competition.

2. Regulations

2.1 Unless otherwise stated, the latest Badminton World Federation rules shall apply.

3. Entries

3.1 Each hostel is limited to enter one team.

4. Umpires

- 4.1 The referee is arranged by the convenor.
- 4.2 During the competition, two persons from each team have to serve as a linesman and a scorer.

5. Withdrawal

- 5.1 Participating team must report to the convenor 5 minutes before the match, otherwise, the team shall be taken as withdrawing from the match.
- 5.2 In case of a dispute, the decision of the referee made according to the relevant rules of badminton shall be final. Should a team oppose to the decision and refuse to play, the team shall be taken as withdrawing from the match.

6. Others

- 6.1 The competition balls will be provided by the convenor.
- 6.2 Amendments of the rules may be made if needed by the Organizer.
