# **Brief Course Description**

This course is designed as a survey of twentieth-century American literature. It introduces students to canonical American literary texts (poetry, prose, fiction, and nonfiction) from 1900 to the present, focusing on the issues of modernism, experimentalism, pluralism, translation, and media. It projects a picture of American literature rooted in the translocal and translingual, a literature that is not confined to national, cultural, or linguistic boundaries.

#### Aims

The course aims to acquaint students with representative works while expanding the traditional canon. It teaches them how to interpret texts in historical and cultural contexts, but more importantly helps them appreciate literature as producers, not merely representations, of culture.

#### **Learning Outcomes**

The course learning outcomes are based on the expectation that students will be able to:

- 1. Interpret both traditional and experimental literary texts;
- 2. Illustrate the ways in which literature acts as a vanguard of social and cultural change;
- 3. Interpret the ways in which the making of a national literature is inseparable from cultural and linguistic infusions from the world;
- 4. Demonstrate skills of analysis required to make sense of literary texts in contexts;
- 5. Writing critically about literature.

#### **Indicative Contents**

- Introduction to the study of American literature
- Presentation of chosen texts to provide extensive and intensive readings and interpretation
- Necessary background to chosen texts
- Presentation of common critical vocabulary
- Strategies and techniques for speaking and writing about literature

## **Teaching Method**

An introductory lecture will provide a framework for readings of chosen texts and sample methods for approaching literature. Subsequently, each lecture will introduce close readings of assigned texts, which the student are required to have read before attending the lecture. Lectures will be supplemented by slides, sound recordings, and videos of literary works and performances. Students are also required to lead the tutorials and present their views independently or in response to the lectures.

### **Measurement of Learning Outcomes**

Students' progress towards the learning outcomes outlined above will be measured by continuous assessment on the students' engagement with the lectures, tutorial discussions, readings, presentations and written assignments. Students' knowledge of the selected texts will be assessed by a final examination at the end of the term.
