# **Brief Course Description**

This course aims to develop the students' ability to carry out extended investigation into a specific topic they have chosen. Students will develop, research and write up the literary, linguistic or practical topic they identified in ENG3006. By producing a long paper, students will be asked to demonstrate and synthesize the subject knowledge, linguistic ability, academic writing skills and analytical power which they have developed over their four years of study.

#### Aims

- 1. Use methods appropriate to the area of study;
- 2. Collect, analyse and evaluate research data or other materials;
- 3. Tackle a research or communicative problem efficiently;
- 4. Argue and reason logically and effectively;
- 5. Provide a fully annotated long essay, or commentary on their practical project, in an appropriate format.

## **Learning Outcomes (generic)**

- 1. Demonstrate powers of analysis across a chosen form of discourse;
- 2. Demonstrate critical engagement with complex material;
- 3. Demonstrate the ability identify and research appropriate questions;
- 4. Produce a coherent, sustained, persuasive written argument;
- 5. Demonstrate the ability to communicate with clarity, confidence (and possibly vividness and elegance);
- 6. Demonstrate meticulous and scholarly presentation of material in the manner required;
- 7. Demonstrate knowledge of the status of empirical evidence and be able to demonstrate an understanding of different methodologies;
- 8. Demonstrate an ability to evaluate and assimilate information from different sources.

### **Indicative Contents**

Students are required to write a paper of about 7,000 words (excluding notes and bibliography) on a topic of their choice, selected from contemporary literary studies

orapplied linguistic studies. Students choosing to write on a practical topic will need to work closely with the Department to research the suitability of the project. These students will not only produce a communicative text or set of texts, but will also write a commentary of at least 5,000 words justifying their use of the appropriate linguistic, discoursal, or literary features.

### **Teaching Method**

There is no formal teaching for this course, but students are required to spend approximately 9 hours a week on the work related to their projects. Supervisors will advise students individually on the use of reference materials, approach, collection and analysis of data, and presentation. However, it is the students' responsibility to ensure that their project progresses in accordance with the schedule set by the Department, prepare for their consultation sessions with the supervisor, and seek their supervisor's advice and assistance as necessary.

We believe that for genuine critical ability to develop, teachers must create an atmosphere which fosters independent inquiry. Thus, in this course students are encouraged to make judgments about particular issues and then learn to effectively organize textual materials that support their arguments. This problem-solving task involves analysis, synthesis, and the evaluation of ideas, all of which are essential to critical thinking.

## **Measurement of Learning Outcomes**

LOs 1-8: through assessment of the final written submission

#### Assessment

- 80% final assessment of the written submission
- 20% for participation (e.g. timely submission of drafts, response to feedback, ability to work independently)

# **Required and Supplementary Readings**

#### **Important Notes:**

- (1) Students are expected to spend a total of 9 hours per week (including consultation with supervisors and independent work) to achieve the course learning outcomes.
