

Minor in Public Policy

Public policy encompasses a wide range of areas including education, health, food, housing, law, transportation, the environment, the economy, culture and recreation and social security. Public policy can also be understood as how governments do a service (or disservice) to their peoples. The public policy minor equips students with the analytical tools to understand public policy, and thus to engage in intelligent public policy debates. The Minor in Public Policy programme enhances students' understanding of Hong Kong's social, economic, and political issues, and prepares them to be responsible citizens.

The Office of the Faculty of Social Sciences coordinates the offering of the Minor in Public Policy.

Students who are not enrolled in the Social and Public Policy Studies Stream/Major of BSocSc Programme may qualify for a Minor in Public Policy after successful completion of 15 credits (five courses) as detailed below:
