



# MScRIM MSc in Risk and Insurance Management 风险及保险管理理学硕士课程

### Special Features 课程特色

- The degree gives an in-depth coverage of the major areas in risk management and insurance, with an emphasis on professional practice.
  - 本课程让学生深入认识风险管理及保险业的主要领域,并注重专业实践。
- The degree helps students obtain professional qualifications such as Chartered Insurance Institute (CII) and Financial Risk Manager (FRM) qualifications.
  - 本课程帮助学生获得如英国特许保险学会(CII)和金融风险管理师(FRM)的专业资格认证。
- The degree covers risk management principles, general insurance, life and health insurance, financial risk management, risk modelling and analysis, insurance law and regulation, wealth management, and financial services markets.
  - 本课程涵盖风险管理原理、一般保险、人寿和健康保险、财务风险管理、风险建模及分析、保险法律和法规、财富管理,以及金融服务市场。
- The inclusion of finance electives increases the appeal of the degree to both students and potential employers.
  - 本课程让学生选修部份金融学科,以加强他们将来就业的竞争力。

## Learning Outcomes 课程学习目标

- Explain the theories and practices of risk management and insurance; 培育学生理解风险管理和保险的理论与实践;
- Devise suitable risk management strategies for different individuals and corporations; 培育学生掌握如何制定合适的个人和公司风险管理策略;
- Demonstrate a mastery of quantitative skills in applying risk models and performing risk analysis; 帮助学生掌握应用风险模型,以及执行风险分析的量化技巧;
- Apply risk management and insurance products to control risk exposures; and 培育学生运用风险管理和保险产品以控制风险;以及
- Explain regulatory compliance and regulations for insurance businesses in the insurance market. 培育学生理解保险市场及业务的法规和监管。

## Admission Requirements 入学条件

#### General qualifications 一般学历要求

• Hold a bachelor's degree awarded by a recognized tertiary institution or have equivalent qualifications, which will be considered on a case-by-case basis.

申请者需持有认可大学的学士学位或拥有其他同等学历(视乎申请者情况作个别考虑)。

#### Language requirements 语言要求

 An applicant whose degree is not from a tertiary institution in Hong Kong or an English-speaking country should obtain a minimum score of 550 (paper-based test) or 79 (internet-based test) in the Test of English as a Foreign Language (TOEFL), a band score of 6.5 or above in the International English Language Testing System (IELTS).

除非持有香港或其他英语国家大学颁发的学位,其他申请人必须符合以下要求:托福考试(TOEFL)最低成绩达550分(纸考)或79分(网考);或雅思考试(IELTS)最低成绩达6.5分。

 Applicants who do not fulfil the above language requirements but have an equivalent score in a recognized test, or an equivalent qualification assessment to prove their language proficiency may be considered on a case-by-case basis.

未达到上述语言要求但持有同等资格的申请者,或有同等资格评估以证明其语言能力的申请者,会作个别考虑。

#### Remarks 注意

• A recent GMAT or GRE test score, while not required, will be helpful in determining admittance into the Programme.

GMAT或GRE成绩並不是入学申请的必需资料,但该成绩可作为录取参考。

#### Pre-entry courses 预科课程

 Applicants with no or limited background in insurance and statistics in their bachelor's degree will be required to pass the pre-entry course(s) "Fundamental of Insurance" and/or "Statistics Workshop" prior to the start of this Programme.

申请者如未曾修读过保险和统计学等科目或对这些科目较少认识,将需于本课程开始之前通过相应预科课程(包括保险基础及统计学)。
