Admission Requirements 入学条件

General qualifications 学历要求

- Hold a bachelor's degree awarded by a recognized tertiary institution or have equivalent qualifications, which will be considered on a case-by-case basis.
- 申请者需持有认可大学的学士学位或拥有其他同等学历（视乎申请者情况作个别考虑）。

Language requirements 语言要求

- English language is the usual medium of teaching and assessment at your university of which your bachelor's or higher degree is obtained. 取得学位的学校全部采用英文授课及考试。
- IELTS (Academics): A band score of 6.0 or above (Taken in 2 years) 雅思（学术组）：总分6.0或以上 (2年以内)
- TOEFL (iBT): 79 or above (Taken in 2 years) 托福 (iBT)：79分或以上 (2年以内)
- CET-6: 450 or above (Taken in 5 years) 大学英语六级考试：450分或以上 (5年以内)
- Applicants who do not fulfil the above language requirements but have an equivalent score in a recognized test, or an equivalent qualification assessment to prove their language proficiency may be considered on a case-by-case basis. 未达到上述语言要求但持有同等资格的申请者，或有同等资格评估以证明其语言能力的申请者，会作个别考虑。

Remarks 注意

- A recent GMAT or GRE test score, while not required, will be helpful in determining admittance into the Programme. GMAT或GRE成绩并不是入学申请的必需资料，但该成绩可作为录取参考。

Pre-entry course 预科课程

- Applicants with no or limited background in finance, accounting, and statistics in their bachelor's degree will be required to pass the pre-entry course (s) "Financial Management" and/or "Statistics" prior to the start of this programme. 若申请者未曾修读过金融、会计及统计学等科目或对这些科目较少认识，将需于本课程开始之前通过相应"财务管理"和"统计学"预科课程。

Scholarships & Financial Assistance 奖学金及学费资助

- Scholarships might be offered to outstanding students on the basis of academic merit. All students admitted to the programme will automatically be the candidates for the scholarships. 奖学金将授予成绩优异的申请者。入读本课程的学生均具备资格成为备选人。
- Wu Ho Loo Ning Scholarship will be awarded to a full-time postgraduate student pursuing a taught postgraduate (TPg) programme in international banking and/or finance (including insurance). 伍何露宁奖学金将授予修读国际银行与金融硕士课程和金融硕士课程（包括保险专业）的全日制授课式学生中的学术成绩优异者。
- Various types of internal and external scholarships are awarded to qualified students based on their academic merit. 不同种类的内部或外部奖学金会授予给符合学术成绩资格的学生。
- Local students are eligible for applying the Extended Non-means Tested Loan Scheme (ENLS). 香港本地学生可申请扩展的免入息审查贷款计划（ENLS）。
