



VolTra International Workcamps 2026

Founded on 16 April 2009, VolTra is a non-governmental voluntary organization (NGO), which is dedicated to promote international voluntary services in Hong Kong through a well-established worldwide network of international workcamp organizations. International workcamps refer to the programs created for participants from different countries to get along with the locals. Participating in workcamps, volunteers would have a chance to get to know, to live, to work, to study and to exchange ideas with the locals and other people from all around the world.

OSA has joined hands with VolTra in the summer of 2011 and since then has been sending students to international workcamps around the world. In view of the positive learning experience and feedback, OSA is again providing subsidy quotas so that students who are interested in engaging in international non-business and community service-related projects can have a chance to participate.

✂ Programme Fee

All the application fees would be paid to VolTra directly. The application fee of each workcamp is different and is listed in the website of VolTra. Please visit “[International Workcamp \(精選工作營\)](#)” to look for workcamps that may suit your interests most.

Other Expenses

Other than the programme fee, participants are responsible for the expenses of air ticket, travel insurance, visa application fee (depends on countries and your passport), domestic transportation fee and living expenses.

Expenses amount depends on the workcamp duration and location.

Applicants are advised to do some research on the cost of the above items and plan your own travel budget.

✂ Subsidy for Lingnan Students

Lingnan full-time undergraduate degree students who are joining workcamps that are **4 – 12 weeks** can apply for subsidy for VolTra International Workcamps. For summer 2026, the University will provide around 15 subsidy quotas to students participating in VolTra International Workcamps.

Eligibility for Receiving the Lingnan Subsidy

1. Full-time undergraduate degree student in all disciplines (including final year students).
2. Must be over 18 years of age.
3. Demonstrate commitment, maturity and the heart to serve.
4. Pass the selection interview conducted by the Office of Student Affairs.
5. Attend all compulsory trainings, debriefing, evaluation and sharing sessions as required.
6. Complete the specific workcamp period in full.
7. Complete all required reports with good quality.

Workcamps that are **NOT** subsidised

Workcamps in the following countries and those countries/cities with red and black travel alert under Outbound Travel Alert (OTA) system, Security Bureau, The HKSAR (<https://www.sb.gov.hk/eng/ota/>) will **NOT** be subsidised.

- * The duration must be **at least 4 weeks** and not more than 12 weeks during the summer month. One can only opt for workcamp with period during **1 Jun – 31 Aug 2026**.
- * The approval of subsidy amount (on Air Ticket + Accommodation) **depends on the duration and location of the confirmed workcamp**. Please note the ceiling amount capped for different locations.
- * Approved subsidy will be released to eligible students approximately in July (most likely after your departure). Please plan your travel budget carefully.

✂ Subsidy Application for 2026 Summer Workcamps

For Lingnan students who wish to apply for the 4 – 12 weeks long workcamps with subsidy from the University, you must follow the following procedures:

- 1) Complete and submit the followings no later than **7 Apr 2026 (by 23:59)**.
 - (a) [Online Application Form](#)
 - (b) University Web Transcript (*submitted via the online application form*)
 - (c) CV (*submitted via the online application form*)
- 2) The Selection Interview will be held on **10 / 14 Apr 2026** on campus. Please indicate your available interview timeslot(s) in the Online Application Form. Confirmed interview arrangement will be sent to you via email on 8 Apr 2026 or before.
- 3) Please attend the Selection Interview punctually. No makeup interview will be arranged for latecomers/absentees.

Lingnan students who wish to apply for VolTra short-term workcamps (meaning less than 4 weeks) please submit the application to VolTra directly as the University will not provide subsidy on this.

✂ Special Reminder to Students

- Please consider your summer plan carefully before making any workcamps application.
- If there is any unforeseeable factor(s) leading to the cancellation or curtailment or delay of the workcamps, students are required to bear all the expenses including but not limited to visa, transportation and accommodation costs (if any) by themselves. VolTra has its cancellation policy in place and you are always reminded to pay attention to the “[Clauses on Applications](#) (「義遊國際工作營」報名流程及費用安排)” on VolTra's website for the details of Application Fee, Amendment Charge and Cancellation Fee.
- One of the requirements for students to receive overseas summer internship subsidy is to complete the specific internship period in full. If students cannot duly complete the internship period, OSA will not provide the related subsidy to the students.
