Brief Course Description

The course will address selected issues in bioethics that have been a matter of much recent controversy: abortion, euthanasia, organ donation, sanctity of life, experimentation with humans and with animals, moral implications of the human genome research, etc. The emphasis will be on the attempt to reconstruct the best reasons for conflicting views and then compare them in a critical way.

Aims

The aims of the course include introducing the students to the main arguments for the opposed views on several hotly contested topics in bioethics. It is expected that they will learn to analyze and evaluate the relevant arguments, and that this will also help them to take sides about these controversial issues in a more reasonable and informed manner.

Learning Outcomes

On completion of the course, students will be able to:

- (LO1) Describe the main different positions on various bioethical dilemmas and the arguments in support of these views.
- (LO2) Evaluate the opposing arguments on these hotly debated issues.
- (LO3) Become aware of how different solutions to bioethical dilemmas are related to social, political, and religious beliefs.
- (LO4) Propose and discuss their personal views on the issues discussed in class.

Indicative Content

- 1. Methods in bioethics
- 2. Abortion
- 3. Euthanasia
- 4. Human genome research
- 5. Experimentation with humans and animals
- 6. Procreation and future generations
- 7. Bioethics and armed conflict
- 8. Human enhancements and life-extending technologies
- 9. Distributive justice in health care

Teaching Method

Lectures and seminar discussions.

Measurement of Learning Outcomes

Students will take/write:

- (1) Short in-class quizzes, in which they will have to answer short questions on the various concepts and theories discussed in class (to assess LO1, LO2, and LO3);
- (2) A final exam, in which they will have to write long essay questions on the content of the course. Students will have to elaborate their views on the theories discussed in class (to assess LO1, LO2, LO3, and LO4);
- (3) A term paper (1500-2000 words) on a topic of the course (to assess mainly LO4). The students will be provided with a list of readings related to the specific topic they choose to write about.
