## Terms of Reference:

a) To consider student disciplinary cases referred to the SDC by the Director of Student Affairs or Heads of Departments/Units and Wardens.
b) To determine/recommend counselling and/or disciplinary actions as appropriate.

Chairman: To be appointed by the President from among the Associate Vice-Presidents
Members: Deans of the three Faculties
Dean of the School of Graduate Studies ${ }^{\#}$
One Warden who is a member of academic staff, appointed by the President
One current full-time student nominated by the Students' Union by name, not by position, appointed by the President

Co-opted One co-opted member appointed by the President, if appropriate Member:

## Sub-group on Academic Misconduct Appeals

## Terms of Reference:

The Sub-group on Academic Misconduct Appeals is delegated by the Student Disciplinary Committee to consider appeals against the decisions of the Boards of Examiners on academic misconduct cases. The Sub-group may confirm, modify or overturn the decisions of the Boards of Examiners as appropriate. The review of each case may include one or both of the following:
a) Review of procedures used by the Boards of Examiners, and/or
b) Review of the merits of the case and the decision on the form of penalties taken by the Boards of Examiners.

The Sub-group will present a summary of cases to the Academic Quality Assurance Committee for Undergraduate Programmes (for undergraduate cases)/Postgraduate Studies Committee (for postgraduate cases) on an annual basis for onward submission to the Senate for noting.

## Membership ${ }^{\wedge}$ :

Chairman: A member of academic staff at the rank of Associate Professor or above, appointed by the President

Members: One representative from each of the three Faculties
One representative from the School of Graduate Studies
Co-opted One co-opted member appointed by the Chairman, if appropriate Member:

Observer: One full-time student nominated by the Students' Union by name, not by position, appointed by the Chairman

Secretary: A member of staff of the Registry
