**Brief Course Description:**

Students are required to work on a short translation project, either from English into Chinese or from Chinese into English. It will be in a direction opposite to that they have chosen or are going to choose for the Translation Project. Students who choose to translate in both directions for the long project (TRA4318) are not allowed to take this course. The source text should be at least 4,500 English words (excluding punctuation marks) or 5,000 Chinese characters words (including punctuation marks) in length. The last 1,500 words or characters are to be translated without supervision.

The course will be offered in the student's final year, subject to the availability of staff resources.

Language of instruction: English / Chinese

**Aims:**

This course will tax the translation skills of students and their honours potential in exercising judgment on the appropriate relationship between the source and the target texts.

**Learning Outcomes (LOs):**

Upon completion of this course, students will be able to:

1. demonstrate an adequate level of competency of both the source and target language for the translation of a moderately complex text;
2. locate items specific to the source culture that may cause problems for the translation of the text;
3. identify the potential readership of the target text;
4. develop appropriate strategies for the translation of the source text by working through a number of drafts;
5. produce a target text which would satisfy a typical user; and
6. use any reference tools that may be related to the translation work at hand.

**Approach to the Short Project:**

1. Selection of texts: in consultation with a full-time teacher of the Department, students will select a text that is related to their intellectual pursuit and that should be able to serve some purposes in the target culture; the chosen text will need to be approved by the Department before the start of the term in which the course is taken.
2. Preliminary reading and research: students are expected to read extensively in the general area from which their text has been chosen, and to conduct some research before attempting any translation. They need to ensure that they have access to reference works for technical or specialized terminology used in the chosen text.

3. Second draft and final version: Students will work independently on the second draft of the translation, based on discussions with the supervisors. The final draft will need to be submitted in the designated format.
4. The introduction: students are required to write without supervision an introduction with at least 2,000 English words for an English translation and 3,000 Chinese characters for a Chinese translation. Those who have chosen to translate two half-length texts may decide for themselves which text to write an introduction to. Depending on the circumstances, students may give an account of the nature of the source text, the purpose of their translation and their intended readership. Most importantly, they should summarize their experience, identify any difficulties encountered, explain their translation strategies, and discuss the limitations of their translation.

**Teaching Method:**

Individual supervision of half an hour every two weeks

In these supervision sessions the supervisor will closely monitor the performance of the student, provide formative feedback based on drafts submitted, and suggest ways of improvement.

Students are required to produce one draft under supervision for the supervised part.

**Assessment:**

Continuous assessment: 100%

The short project will be assessed by the supervisor and at least one other teacher. The procedure for the assessment of the short project is as follows.

1. After supervisors submit their marks, a double-blind second assessment exercise will be conducted for all short projects.
2. Second assessment will be mainly based on the unsupervised part and the second half of the first draft, but reference may be made to the supervised part if deemed necessary.
3. When the grade given by the supervisor and that by the second assessor differ by one sub-grade, the former will prevail. When they differ by two sub-grades, the middle grade will be taken.

4. If the two grades differ by more than two sub-grades, the short project will be subjected to third assessment.
5. Supervisors may appeal against any upward or downward adjustment resulting from second or third assessment. These appeals are handled by a “Judge of Final Appeal”.
6. The “Judge of Final Appeal” also handles appeals lodged by students.
7. Cases mentioned in Points 5 and 6 will be handled by another member of staff if the short project concerned has been supervised by the “Judge of Final Appeal”.

**Important Notes:**

- (1) Students are expected to spend a total of 9 hours (i.e. 0.5 hour of class contact and 8.5 hours of personal study) per week to achieve the course learning outcomes.
- (2) Students shall be aware of the University regulations about dishonest practice in course work, tests and examinations, and the possible consequences as stipulated in the Regulations Governing University Examinations. In particular, plagiarism, being a kind of dishonest practice, is “the presentation of another person’s work without proper acknowledgement of the source, including exact phrases, or summarised ideas, or even footnotes/citations, whether protected by copyright or not, as the student’s own work”. Students are required to strictly follow university regulations governing academic integrity and honesty.
- (3) Students are required to submit writing assignment(s) using Turnitin.
